INTRODUCTION

In recent years, menstrual inequity has become a pressing issue across the United States, with individuals and organizations alike advocating for policy changes across state- and national-level systems for education, access, and infrastructure. Days for Girls (DfG) in collaboration with the The Association for Cleaning and Facility Solutions (ISSA) has developed this high-level analysis on the legislative landscape for menstrual health policy of each state within the United States. Dedicated to providing information and actionable recommendations for the advancement of menstrual equity legislation, the Menstrual Health Report Cards include state-level evaluations on current menstrual health mandates across multiple dimensions of equity and access. The evaluation encompasses five main criteria: product taxation, provision of products in schools, provision of products in public buildings, provision of products in incarceration facilities, and Good Samaritan liability protections for product donation. Alongside the analysis of each state's landscape within the criteria, recommendations are provided for each state to enhance its menstrual health policy landscape.

These report cards were a collaborative effort to provide insight on menstrual health inequities for the average American, as well as with a special focus on vulnerable populations including incarcerated individuals and school-aged children.

Key findings include:

1. 15 states scored a “D” or below overall grade. Only 5 states achieved an overall “A” or “A-” grade.
2. Only 5 states have Good Samaritan liability protections for the donation of period products, despite the bipartisan support and lack of fiscal note on such legislation.
3. For each of the five policy dimensions explored, both Republican- and Democrat-led model states have achieved “A” grades, demonstrating the nonpartisan nature of the topic of menstrual health.

These findings among others indicate the necessity for improved policy environments across the United States to adequately and equitably support Americans to manage their periods in a safe, healthy, and dignified manner. DfG and ISSA are excited to share these report cards with legislators and the broader community of menstrual health advocates to work together in shaping the menstrual landscape of the United States.

Menstrual Products in Incarceration Facilities	B	Menstrual products are required to be provided at no cost to inmates in incarceration facilities, but only upon request. ⁴
Menstrual Products in Public Buildings	F	Alabama does not have a law requiring public buildings to provide menstrual products.
Good Samaritan Menstrual Product Donations	F	Alabama does not have a Good Samaritan Menstrual Product Donation law.

Recommendations

1. Implement a Good Samaritan law to protect menstrual product donations made in good faith from civil & criminal liability.
2. Expand the existing menstrual product grant program to fund menstrual products for all schools in Alabama.
3. Make menstrual products available in incarceration facilities without requiring individuals to request them.

POLICY AREA MODELS

Menstrual Product Taxation

- “A” grade states do not have a value-added tax on menstrual products.
- Texas (R, 2023) and Colorado (D, 2022) are model states that successfully removed their value-added tax on menstrual products.

Menstrual Products in Schools

- “A” grade states both fund and require menstrual products in public schools.
- Ohio (R, 2023) and Minnesota (Split, 2024) are model states that both fund and require the provision of menstrual products in schools.

Menstrual Products in Incarceration Facilities

- “A” grade states provide unrestricted access to the needed amount of product at no cost to incarcerated individuals.
- Florida (R, 2019) and New York (D, 2019) are model states that require the unrestricted provision of an appropriate amount of menstrual products without charge.

Menstrual Products in Public Buildings

- “A” grade states require government buildings, civil service buildings, and/or shelters to provide period products.
- Utah (R, 2023) and Pennsylvania (Split, 2024) are two states that require the provision of menstrual products in state-owned buildings.

Good Samaritan Menstrual Product Donation Laws

- “A” grade states provide “Good Samaritan” liability protection for donated menstrual products. This protection enables manufacturers, retailers, nonprofit organizations, and individuals to donate and distribute products in good faith without fear of frivolous lawsuits.
- Tennessee (R, 2021) and Illinois (D, 2021) are model states that have liability protections in place for the donation of menstrual products.

Menstrual Health Education

Menstrual health education policies vary widely from state to state. Model curricula details menarche, menstruation, the menstrual cycle, menstrual product usage, premenstrual syndrome, menstrual disorders, and menopause in an age-appropriate and destigmatizing way.

A: The state funds & requires the provision of products

D: The state has a limited grant program for the provision of products

Menstrual Products in Incarceration Facilities (20%)

A: Unrestricted access to the needed amount of product at no cost

B: Access to the needed amount of product at no cost, but only upon request

C: Access to product at no cost at a fixed allotment per month

A: State-owned public buildings are required to provide period products
